Limited Tender is invited for disposal of unserviceable store items at ICAR – Krishi Vigyan Kendra, Arattuvazhi Beach, Narakkal Post, Ernakulam district. Interested parties may please quote their rates on plain paper in a sealed cover superscribed as "QUOTATION FOR DISPOSAL OF UNSERVICEABLE ITEMS".

Terms & Conditions:

- 1. The Earnest Money Deposit (EMD) for Rs.10,000/- (Rupees Ten thousand only) in the form of Demand Draft drawn in favour of "ICAR Unit-CMFRI, Kochi" payable at State Bank of India, Ernakulam should be remitted along with the quotation. Quotation without EMD will be rejected.
- 2. Tender fee not required
- 3. The bidders should have a valid GST registration certificate. Quotation of the parties without having GST registration will not be accepted.
- 4. The unserviceable items can be inspected by the parties from 24.07.2023 to 27.07.2023 at the premises of ICAR Krishi Vigyan Kendra, Arattuvazhi Beach, Narakkal Post, Ernakulam between 11.00 am and 4.00 pm in the presence of the Inventory Management Officer of the KVK. Inspection of items will not be allowed after 27.07.2023
- 5. The sealed quotations will be accepted up to 11.30 am on 10.08.2023 and will be opened at 12.00 pm on the same day.
- 6. Late bids, that is, bids received after 11.30 am on 10.08.2023 will not be accepted.

- 7. The quotations will be opened in the presence of the bidders. No other persons except the bidders will be allowed to participate at the time of opening the quotations.
- 8. The price quote should be inclusive of 18% GST as applicable.
- 9. The successful highest bidder should remit 25% of the total bid value on the spot either in cash or in the form of Demand Draft drawn in favour of "ICAR Unit-CMFRI", Kochi payable at State Bank of India, Ernakulam.
- 10. The EMD will be returned as soon as the formalities are over except in the case of the three highest bidders.
- 11. The successful highest bidder should remit the balance amount (75% of the total bid value quoted) within 16.08.2023 failing which the EMD amount of Rs.10,000/- will be forfeited.
- 12. The disposed items will be handed over to the successful highest bidder only after receipt of full payment (total bid value quoted).
- 13. The bid items will have to be cleared from the KVK premises at the cost of the successful highest bidder within the date prescribed on the acceptance letter to be issued by this KVK. In case of dispute regarding loading/unloading etc. the same should be settled by the successful highest bidder himself/herself outside the Institute compound.
